



Visitor's tax, will finance actions in the tourism sector including support to accommodation facilities, maintenance and renovations of cultural and natural heritage sites, in addition to improvements to local public services.

WHO PAYS THE TAX? TO WHOM DO I PAY THE TAX?

Everyone who spends one or more nights in the accommodation facilities of Praiano. The visitor's tax is paid to the owner/manager of the accommodation facility, who will provide a receipt of payment.

HOW MUCH IS THE TAX?

The tax is per person, per night (for a maximum of 7 overnights). From November 1st to March 31st of the following year, the tax is not due.

- ❖ **For widespread hotels** the reference rate is the hotel rate;
- ❖ **For transitional releases** for exclusively tourist purposes, pursuant to Article 53 of Legislative Decree no. 79/2001, lasting more than 30 days, a flat rate tax of €200.00 is established.

WHO IS EXEMPT FROM THE TAX?

- **Children under 10** years of age;
- People who stay at **Youth Hostels**;
- **Persons who assist** in-patients in health facilities (one assistant per patient);
The exemption is subject to a declaration (under Articles 46 and 47 of Italian Presidential Decree No. 445/2000 and subsequent amendments), and that the accommodation is provided for the patients carer or assistant.
- **Non self-sufficient disabled persons**, with medical certificates, and their assistant/carer;
- **The bus drivers and one tour guide** of tour groups organized by official travel agencies.
The exemption is applied to one coach driver and tour guide per 25 participants.

HOW TO PAY THE TAX? (for Hotels/accommodation facilities)

The Italian law allowed payment via the digital system PAGOPA.
All Hotels/accommodation facilities had to register in and fill it entering data every month.

WHEN DO HOTELS / ACCOMMODATION FACILITIES HAVE TO PAY?

From 2021 the deadline becomes monthly for all hotels/accommodation facilities and is set for the sixteenth day from the end of each.
