Administrative detention of vehicle is an ancillary administrative sanction resulting from some violations of the Highway Code and consists in temporarily depriving the owner of the vehicle's availability as the vehicle's document is withheld by the competent police authority.

During the standstill period the vehicle cannot, therefore, be used.

At the end of the period of detention, the police authority will return the document of circulation to entitled person.

Bicycle is a vehicle and its road use is governed by the Highway Code. It is forbidden:

- To carry other persons on the bicycle unless the person is less than 8 years old and sits on an approved child seat;
- To lead animals;
- To be towed by another vehicle.

If by accident you hit a pedestrian during the ride on the sidewalks, in addition to the fine, you will be held to pay all the damages that you caused to the injured person.

In case of particular violations of the Highway Code some points are deducted from the driver's license.

If it has not been possible to identify the driver the fine is notified to the owner of the vehicle.

In this case, the owner must provide the police authority the personal and driver's license data of the person who was driving the vehicle (even if it is the owner).

If the aforementioned communication is not made, a further fine must be paid by the owner of the vehicle.

Local police are the police force of the municipalities. Their duties are mainly administrative in nature, such as traffic management, overseeing licenses and enforcing urban regulations. They operate under the authority of Italian local governments and mostly act under the directives of the mayor's office.

They also cooperate with national police forces. Additional tasks include environmental and wildlife protection and ceremonial duties.

Riding a bicycle has its rules. It is mandatory:

- To use the bicycle lanes when they exist. If there are no bicycle lanes you have to ride as near as possible to the right edge of the roadway;
- In order to turn, turn the arm out;
- Use lights (lighting devices) after half an hour from the sunset until half an hour before the sunrise and in case of poor visibility.

If you do not comply with these rules, a fine will be applied.

The Italian driving license provides an initial number of 20 points, increased by 2 points every two years if no violations are committed, up to a maximum of 30 points.

Once a number of driving license points are lost, these can be recovered by attending driving school lessons or by not committing violations for a 2-years period.

Once all driving license points are lost the holder must undergo the revision of the license, under penalty of suspension of the driving license.

The local police deal with many different issues: compliance with the highway code, traffic management, penalties in case of violations, illegal trade, safety and control over the territory.

In small municipalities the service is generally not provided continuously, 24 hours a day, as in larger cities. In less populated towns, the primary activities are road management and controls on commercial activities, while in metropolitan areas, they focus on road accidents and public order.
